➤ None of subject’s vehicle was present at location.

- **06/11/07 9:45PM - En route to Subject’s residence location XXXXXX Ave, White Plains, New York.** The following activity was noted:

➤ At about 9:45 PM we observed possible subject arriving at the location in the white Lincoln Navigator. Subject pulled vehicle into the back yard of residence and entered location.

- **06/12/07 8:00AM – En route to Subject’s work location Westchester County, White Plains, New York.** The following activity was noted:

➤ Wearing a body camera proceeded into the XXXXX restaurant-location reported as claimant’s employer. (Works as cashier). Observed 3 females working in the restaurant area. None of subjects were wearing nametags **but one of employees fit the age and description of our Claimant.**

➤ Obtained video of possible subject working as a waitress.

➤ **Proceeded to Subject’s residence at about 9:30PM –in attempt to locate/video subject coming home from work location. Subject vehicle arrived at location but subject entered**

- 6/21/07 – 9:35AM - **En route to Subject's residence location XXXXXXX, White Plains, New York.** The following activity was noted:
  - Observed 2 females arriving at location operating XXXXXXX
  - Females carried suitcases up the staircase to residence and entered the building; subjects stayed at location for a short period of time, returned to the above vehicle and left the location.
- 6/22/07 – 8:55AM - **En route to Subject's residence location XXXXXXX Ave, White Plains, New York.** The following activity was noted:
  - At about 8:24 AM we observed another UK female leave the location, walk to a nearby store, purchase flowers and return to the residence.
  - **At about 8:55PM we observed a female operating XXXXXXX (registered to our subject XXXXX) arriving at the residence. We observed same subject that we had observed/videoed working at XXXXXXX, Westchester County, NY exiting the vehicle and going into the residence. We were able to confirm ID of subject as XXXXXX.**

- **There are no cashiers at this location, all subjects/waitresses work the cash registers. Subject was not accurate in her description of job duties.**
